Updates to RESP and RDSP applications and forms



As we communicated earlier in our <u>winter newsletter</u>, Mackenzie has updated its applications for RESPs and RDSPs to align with Employment and Social Development Canada (ESDC) data collection practices. ESDC now collects gender instead of sex and has added a non-binary gender option.

Updated ESDC forms

The following RESP forms have been updated to reflect the new gender option:

Grant applications (mandatory as of May 1, 2024)

- Application: Canada Education Savings Grant (CESG) and Canada Learning Bond (CLB) – SDE 0093
 - o Annex A: Additional Beneficiaries SDE 0093-A
 - Annex B: Primary Caregiver or their spouse and/or Custodial Parent/Legal Guardian – SDE 0093-B
 - Annex D: Application British Columbia Training and Education Savings Grant (BCTESG) – SDE 0093-D
- Canada Learning Bond (CLB) Application for Adult Beneficiaries SDE 0107

Transfer forms (mandatory as of May 1, 2024)

- RESP transfer form & applicable annexes
 - Part A: Subscriber Request SDE 0100 Part A
 - o Annex 1: Additional Beneficiaries SDE 0100 Annex 1
 - o Part B: Receiving Promoter SDE 0100 Part B
 - Part C: Relinquishing Promoter SDE 0100 Part C

Please note, there are no changes to RDSP forms related to the Canada Disability Savings Grant and Bond, as those forms don't collect sex or gender data for beneficiaries or holders.



Timelines for use

Updated ESDC forms and grant applications for RESP (dated 2023-05)	These are mandatory as of May 1, 2024. Older versions of the form will be rejected after that date, and requests will need to be resubmitted using the updated versions.
Mackenzie RESP & RDSP applications	Mackenzie will continue to accept the previous versions of our RESP and RDSP applications unti June 28, 2024.

Quebec Education Savings Incentive (QESI)
