Management Discussion of Fund Performance

June 5, 2023

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the Fund's performance and outlook in the year ended March 31, 2023 (the "period"). If the Fund was established during the period, "period" represents the period since inception.

In this report, "Mackenzie" and "the Manager" refer to Mackenzie Financial Corporation, the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

Investment Objective and Strategies

The Fund seeks long-term growth and current income by investing primarily in a combination of equity and fixed income securities in Canada and/or the United States. The Fund's asset mix will generally range between 40%–60% equities and 40%–60% fixed income securities.

Risk

The risks of the Fund remain as discussed in the Fund's Simplified Prospectus.

The Fund is suitable for medium- to long-term investors looking for a North American balanced fund to hold as part of their portfolio, who can handle the volatility of stock and bond markets, and who have a low to medium tolerance for risk.

Results of Operations

Investment Performance

The performance of all series in the current and previous periods is shown in the *Past Performance* section of the report. Performance will vary by series primarily because fees and expenses differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Fund Formation and Series Information* section of this report for the varying management and administration fees payable by each series. The following comparison to market indices is intended to help investors understand the Fund's performance relative to the general performance of the markets. However, the Fund's mandate may be different from that of the indices shown.

During the period, the Fund's Series A securities returned -0.5% (after deducting fees and expenses paid by the series). This compares with a return of -1.5% for a blended index composed of a 50% weighting in the Fund's broad-based index, the FTSE Canada Universe Bond Index (returned -2.0%), a 37.5% weighting in the S&P 500 Index (returned -0.1%) and a 12.5% weighting in the S&P/TSX Composite Index (returned -5.2%). All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

Canadian and U.S. equities fell over the period in local currency terms, driven lower by rising interest rates, volatile commodity prices and forecasts of economic weakness. Energy prices were relatively high, bolstered by the Russia–Ukraine war. In Canada, resilient consumer spending supported consumer discretionary and consumer staples stocks. In the United States, large-capitalization value stocks outperformed growth stocks as bond yields rose. In response to persistently high inflation, the Bank of Canada raised its policy rate by 400 basis points, to 4.50% from 0.50%. As a result, Canadian government and corporate bond yields increased significantly.

Within the S&P 500 Index, energy, consumer staples and industrials were the strongest sectors in Canadian dollar terms, while real estate, consumer discretionary and communication services were the weakest.

Within the S&P/TSX Composite Index, consumer staples, consumer discretionary and industrials were the strongest sectors, while health care, real estate and financials were the weakest.

The following discussion reflects the Fund's allocation decisions and the activities and performance of its underlying investment funds and other directly held securities. The Fund outperformed the broad-based index because of the Fund's allocation to U.S. equities, which outperformed Canadian fixed income over the period. Given the Fund's mandate, the return of the blended index is a more meaningful comparison.

The Fund outperformed the blended index, with the equity and fixed income portfolios outperforming the equity and fixed income portions of the blended index.

Within the fixed income portion of the Fund, overweight exposure to corporate bonds contributed to performance. Conversely, holdings in government bonds, particularly foreign government bonds, detracted from performance.

Within the equity portion of the Fund, stock selection in the information technology, industrials and financials sectors contributed to performance. An underweight position and stock selection in the consumer discretionary sector also contributed to performance. In country terms, stock selection in the United States and Canada contributed to performance. Conversely, stock selection in the health care sector and underweight exposure to the energy sector detracted from performance.

Hedging of foreign currency exposure detracted from performance as a result of the overall appreciation of the hedged currencies relative to the Canadian dollar.

Over the period, the Fund's exposure to equities increased as a result of portfolio activity and market movements. Within the fixed income portfolio, exposure to Canada increased because of the Canadian economy's higher sensitivity to interest rates.

Net Assets

The Fund's net assets increased by 505.7% during the period to \$9.1 million. This change was composed primarily of \$0.3 million in net income (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and an increase of \$7.3 million due to net securityholder activity (including sales, redemptions and cash distributions).

Fees and Expenses

The management expense ratio ("MER") for each series during the year ended March 31, 2023, was generally similar to the annualized MER for the period ended March 31, 2022. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

Recent Developments

In the equity portfolio management team's view, the elevated and persistent inflation that prompted central banks to undertake the fastest monetary policy tightening in history was the largest challenge facing stock markets in 2022, as higher borrowing costs and lower spending weighed on economic growth. While goods inflation has fallen, the team expects services inflation to persist. In the team's opinion, the risks of recession have increased following the collapse of Silicon Valley Bank in the United States. Against this backdrop, the team believes that focusing on companies whose growth is driven more by long-term business trends than by short-term economic conditions should benefit the portfolio's performance.

The fixed income portfolio management team expects volatility and uncertainty in fixed income markets to continue for the rest of 2023. By the end of the period, inflation in Canada and the United States was easing but remained elevated. The team believes that the U.S. Federal Reserve could pause rate increases in 2023, while rate cuts are unlikely as long as the global economy is resilient and inflation remains elevated. In Europe, the team believes rates should rise further in response to continuing higher core inflation.

On September 29, 2022, the Fund was renamed Mackenzie Bluewater North American Balanced Fund, and underlying fund Mackenzie North American Equity Fund was renamed Mackenzie Bluewater North American Equity Fund.

Effective March 31, 2023, KPMG LLP was appointed as the auditor of the Fund.

Related Party Transactions

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to the Manager at the annual rates specified under *Fund Formation and Series Information* in this report and as more fully described in the Prospectus. In return for the administration fees, the Manager pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not included in management fees. See also *Management Fees*.

Other Related Party Transactions

At March 31, 2023, Mackenzie had an investment of \$0.02 million in the Fund (0.2% of the Fund's NAV).

The Manager relied on an approval provided by the Mackenzie Funds' Independent Review Committee to appoint KPMG LLP as the auditor of the Fund, effective March 31, 2023.

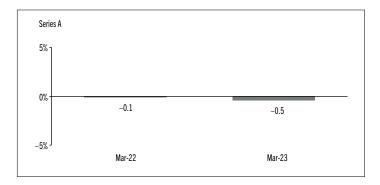

Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by the Manager to pay for the costs of managing the investment portfolio of the Fund and/or the underlying fund(s), as applicable, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, and providing other services. The Manager also used the management fees to fund sales commissions, trailing commissions and any other compensation (collectively "distribution-related payments") to registered dealers and brokers whose clients invest in the Fund.

The following dealers affiliated with the Manager may be entitled to distribution-related payments from the Manager on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation and Investors Group Financial Services Inc.

The Manager used approximately 42% of the total management fee revenues received from all Mackenzie funds during the period to fund distribution-related payments to registered dealers and brokers. In comparison, such distribution-related payments for the Fund represented on average 41% of the management fees paid by all applicable series of the Fund during the period. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series.

Series AR securities are offered to retail investors in a Registered Disability Savings Plan offered by Mackenzie.

Series D securities are offered to retail investors investing a minimum of \$500 through a discount brokerage or other account approved by Mackenzie.

Series F, Series F5 and Series F8 securities are offered to investors who are enrolled in a dealer-sponsored fee-for-service or wrap program, who are subject to an asset-based fee rather than commissions on each transaction and who invest at least \$500 (\$5,000 for Series F5 and Series F8); they are also available to employees of Mackenzie and its subsidiaries, and directors of Mackenzie. The sales charge under the sales charge purchase option is negotiated by the investor with their dealer. Securities purchased before June 1, 2022, under the redemption charge purchase option, low-load 3 purchase option and low-load 2 purchase option (collectively the "deferred sales charge purchase options") may continue to be held in investor accounts. Investors may switch from securities of a Mackenzie fund previously purchased under these deferred sales charge purchase options to securities of other Mackenzie funds, under the same purchase option, until such time as the redemption schedule has expired.
